## 你的權利是什麼？

在美國生活嘅每一個人都有  
憲法權利

你有權去：

- 保持沉默
- 要求移民執法人員出示身份證 / 法庭手令
- 紀錄事件
- 拒絕佢哋進入私人地方(如果有手令)

# 如果你喺公共場所畀移民官截停

- 保持冷靜
- 詢問您是否被逮捕或是否可以離開
- 詢問他們是否有拘捕令
- 請記住,您可以選擇保持沉默 - 您有權說“我希望保持沉默”
- 有權不透露您移民身份的任何詳細信息

# 如果你揸車嘅時候畀移民官截停

停車

安全

出示文件

駕駛執照、車輛登  
記證、保險證明

搜查？

如果警察要求檢查你嘅車，你可以拒絕同意搜查，但如果佢哋有犯罪證據，可以在不用你同意嘅情況下進行搜查

權利保持沈默

司機同乘客都有權保持沉默。乘客可以要求離開。

# 如果移民官到我屋企，怎麼做？

- 你有權唔開門。你可以透過門或者窗同佢哋說話。
- 你有權要求出示由法官簽署嘅手令。可以叫佢哋透過窗或者從門下遞手令給你看。
- 確保手令上嘅姓名同地址係正確。
- 如果移民官冇經你同意就入屋，你有權說：「我唔同意。」

# 如果移民官到我工作地方，怎麼辦？

- 移民官可以進入對公眾開放的區域，例如餐廳座位、接待區
- 非對公眾開放的私人區域或員工辦公室需要法官簽署的手令
- 確認手令公司名稱和地址正確，且由法官簽署
- 未經同意進入，你可以說：「我吾同意」

- 記下家中成員過敏、健康狀況及藥物清單
- 記下學校、工作單位電話
- 原國籍領事館, 律師/認可代表電話
- 出行前,請確認你持有正確的文件與旅行授權和
- 諮詢移民律師或司法部認可代表



## 重要文件 需妥善保管且易於取用：

- 有效護照及ID
- 出生證明及結婚證明
- 外僑號碼(又稱 A-Number)，盡量記住此號碼
- 小朋友的疫苗接種卡
- 社會安全卡
- 照顧人宣誓書
- 財產所有權證明

## 如果被移民局 (ICE) 拘留應該 做嘅事：

- 你有權保持沉默，
- 只同律師討論移民身份。
- 有未明白文件或未諮詢律師前唔好簽署。
- 可要求律師並打電話，提供 A-號碼讓律師或家人找到你。
