## 你的權利是什麼？

在美國生活嘅每一個人都有  
憲法權利

你有權去：

- 保持沉默
- 要求移民執法人員出示身份證 / 法庭手令
- 紀錄事件
- 拒絕佢哋進入私人地方(如果有手令)

# 如果你喺公共場所畀移民官截停

- 保持冷靜
- 詢問您是否被逮捕或是否可以離開
- 詢問他們是否有拘捕令
- 請記住，您可以選擇保持沉默 - 您有權說“我希望保持沉默”
- 有權不透露您移民身份的任何詳細信息

搜查？

如果警察要求檢查你嘅車，你可以拒絕同意搜查，但如果佢哋有犯罪證據，可以在不用你同意嘅情況下進行搜查



權利保持沈默

司機同乘客都有權保持沉默。乘客可以要求離開。

# 如果移民官到我屋企，怎麼做？

- 你有權唔開門。你可以透過門或者窗同佢哋說話。
- 你有權要求出示由法官簽署嘅手令。可以叫佢哋透過窗或者從門下遞手令給你看。
- 確保手令上嘅姓名同地址係正確。
- 如果移民官冇經你同意就入屋，你有權說：「我唔同意。」

# 如果移民官到我工作地方，怎麼辦？

- 移民官可以進入對公眾開放的區域，例如餐廳座位、接待區
- 非對公眾開放的私人區域或員工辦公室需要法官簽署的手令
- 確認手令公司名稱和地址正確，且由法官簽署
- 未經同意進入，你可以說：「我唔同意」

 place where the property was taken.

The officer executing this warrant, or an officer present during the execution of the warrant, must prepare an  
 inventory as required by law and promptly return this warrant and inventory to United States Magistrate Judge

- 記下家中成員過敏、健康狀況及藥物清單
- 記下學校、工作單位電話
- 原國籍領事館, 律師/認可代表電話
- 出行前, 請確認你持有正確的文件與旅行授權和
- 諮詢移民律師或司法部認可代表

# 重要文件 需妥善保管且易於取用：

- 有效護照及ID
- 出生證明及結婚證明
- 外僑號碼(又稱 A-Number)，盡量記住此號碼
- 小朋友的疫苗接種卡
- 社會安全卡
- 照顧人宣誓書
- 財產所有權證明

# 如果被移民局 (ICE) 拘留應該 做嘅事：

- 你有權保持沉默，
- 只同律師討論移民身份。
- 有未明白文件或未諮詢律師前唔好簽署。
- 可要求律師並打電話，提供 A-號碼讓律師或家人找到你。
