#### A. RECOMMENDATIONS:

THAT the Board of Library Commissioners ("Board"):

1. Approve an appropriation of \$300,000 from the Library's Unreserved and Undesignated Fund Balance (UUFB), Fund 300, Department 44, Cash Balance, to the accounts listed below in Fund 300, Department 44:

## B. FACTUAL SUMMARY:

- 1. The Unreserved and Undesignated Fund Balance (UUFB) consists of prior year funds that were unappropriated and disencumbered at the end of the fiscal year. Funds in the UUFB are used for current year appropriations, unplanned events and for projects previously funded which could not be completed in the prior fiscal year. The funds are a result of projects that were delayed and services which could not be completed and also salary savings from vacant positions which could not be filled.
- 2. Funds in the amount of \$300,000 are requested to be appropriated from the UUFB for the Library's 2023-24 Library Materials budget to support increased demand for e-media.
- 3. Funds in the amount of \$350,000 are requested to be appropriated for the Library Trust Fund to be used for expenditures necessary for the operation and management of Angel City Press at LAPL and to reimburse the past owners of Angel City Press for expenses incurred.
- 4. Library staff requests approval to transfer \$900,000 from the Office and Administrative Account (6010) to the Contractual Services Account (3040) to fund contracts for two E-rate projects: Network CAT6 Data Re-cabling Services for 31 Branch Libraries, and Main Uninterruptible Power Supply (UPS) for the Central Library's Computer Server Room. Sufficient funds are available in Account 6010 for this transfer.
