A. RECOMMENDATIONS

THAT the Board of Library Commissioners (Board):

- 1. Approve the amendment to correct the account number for the California Library Literacy Services (CLLS) grant for fiscal year 2022-23 that was approved on October 27, 2022 in the amount of \$243,240. The funds must be deposited in Trust Fund 419, Account 371.
- 2. Authorize the City Librarian, or designee, to make technical and clerical corrections, if needed, to the original acceptance of the grant on October 27, 2022, and to this amendment.
- 3. Adopt the attached Resolution regarding the amendment to correct the account number for the CLLS grant for fiscal year 2022-23.

B. FINDINGS

- 1. On August 24, 2022, the California State Library announced that the Los Angeles Public Library (LAPL) Adult Literacy Services and Family Literacy Services grant application was accepted.
- 2. On October 27, 2022, the Board of Library Commissioners accepted the California Library Literacy Services (CLLS) grant in the amount of \$243,240.
- 3. On November 30, 2022, an error was found in Recommendation 2 of the October 27, 2022 Board Report that needs to be amended. The funds must be deposited in Trust Fund 419, Account 371 instead of Account 366.
- 4. LAPL must encumber the grant funds by June 30, 2023, and fully expend the funds, in accordance with the approved budget on file with the State Library, by December 31, 2023.
