SUBJECT: APPROVAL TO EXERCISE THE OPTION TO TEMPORARILY EXTEND

CONTRACT NO. 769 WITH USBT PROPERTY OWNER LP FOR THE MAINTENANCE OF CENTRAL LIBRARY LANDSCAPE AND HARDSCAPE

AREAS

A. RECOMMENDATIONS:

THAT the Board of Library Commissioners (Board):

- 1. Approve, in accordance with Section 4.2(c) of Contract No. 769 with USBT Property Owner LP (USBT), the exercising of the option to temporarily extend the contract until January 3, 2024, for the maintenance of Central Library landscape and hardscape areas.
- 2. Authorize the City Librarian to transmit a formal notice to USBT, substantially in the form shown in Attachment A, regarding the approval to exercise the option to temporarily extend Contract No. 769.
- 3. Authorize the City Librarian and the City Attorney to make technical and clerical corrections, if needed, to the formal notice.
- 4. Adopt the attached Resolution regarding the Board approval to exercise the option to temporarily extend Contract No. 769 and authorizing the City Librarian to transmit the formal notice to USBT.

B. FINDINGS:

- On October 4, 2013, the Library and Beringia Central LLC, entered into Contract No. 769 for the maintenance of the Central Library landscape and hardscape areas, including Maguire Gardens. On April 23, 2021, the First Amendment to Contract No. 769 was executed to reflect USBT as the new owner of the US Bank Tower. The contract was set to expire on August 3, 2023, and allows the Library the option to exercise a temporary extension to postpone the termination date until January 3, 2024.
- 2. On September 25, 2023, Library staff transmitted written correspondence to USBT stating the Library's desire to exercise the temporary extension option and the intent to present the matter to the Board for consideration.
- 3. Upon approval of this report, the City Librarian will transmit formal written notice (Attachment A) to USBT stating that the Board approved the exercising of the option under Section 4.2(c) of Contract No. 769 to temporarily extend the contract until January 3, 2024.
- 4. All other terms and conditions of Contract No. 769 shall remain in full effect.

- 5. Library staff are currently in discussions with USBT regarding a new agreement for the maintenance of Central Library landscape and hardscape areas, including Maguire Gardens.
- 6. The formal written notice has been reviewed by the City Attorney and is ready to be transmitted to USBT upon approval of this report.
