# WHAT ARE VETERAN STATUTES?

Certain statutes and case laws can help veterans and military personnel receive alternative sentencing taking into account their military service and mental health conditions.

The U.S. Supreme Court has stated that our country has <u>"a long tradition of according leniency to veterans in recognition of their service, especially for those who fought on the front lines . . ." A re-hearing on sentencing in a death penalty case was granted. See *Porter v. McCollum*, 558 U.S. 30, 130 S.Ct. 447, 455-56 (2009)</u>

Tell your attorney you are a veteran or a member of the military. Make sure to speak with your attorney about the criminal statutes which apply to veterans and military personnel. Get the MIL100 form available online at the web address below, which discusses the statutes, and learn about them. The MIL 100 form does not need to be completed to use the statutes.

The court will appoint an attorney to represent you at your first court appearance if you can't afford an attorney. This is the only system for pro bono representation in criminal cases.

### <u>Penal Code Section 1170.9</u> <u>Alternative Sentencing</u>

This statue allows for treatment instead of incarceration. Options include different kinds of restorative relief including reducing felonies to misdemeanors, dismissing of fees and fines, and the sealing of records.

### Penal Code Section 1170.91 PTSD

This statute allows for conditions such as Post Traumatic Stress Disorder (PTSD) to be used for mitigation in sentencing.

## <u>Penal Code Section 1001.80</u> <u>Misdemeanor Pre Plea Military Diversion</u>

This statute allows some veterans & military to do treatment programs instead of incarceration. If successfully completed, cases will be dismissed.

# Penal Code 858 Court notification

This statute mandates the court to notify veterans about all veteran statutes. Courts are required to provide an MIL 100 form upon request.

### **Prop 47**

Proposition 47 helps to reduce some felonies to misdemeanors. In Los Angeles County, public defenders and others help people with this process. http://myprop47.org
